
#### The mission

#### The context

Despite its economic, social and cultural importance in Africa, small-scale fisheries remain the poor relation of development policies.

The looting of resources through illegal uncontrolled unregulated fishing is now jeopardizing the survival of fisheries communities and is one of the greatest threats to future generations.

Organisations grouping professionals are being established in various countries, but alone, they are unable to stop the scourge and influence fisheries policies.

Thus, aware of the problems facing the sector and the urgency of finding solutions, a group was formed and took the initiative to move towards an African Confederation of Small-Scale Fisheries Professional Organisations.



### The Plan of Action

**Main objective**: To make the Confederation, and the national federations which are affiliated to it, functional and operational while enabling them to get involved and to participate effectively with their governments in all that relates to artisanal fishing and which promotes the taking into account of the actors' concerns in the definition of the policies and programs concerning them.

#### Institutional

 Commit to the grassroots development of small-scale fisheries professional organisations;

#### Governance

- Work resolutely at establishing good governance in all the member organisations;
- Defend the mainstreaming of gender in general and women in particular in fisheries policies;
- Elaborate monitoring and assessment guidelines;

#### Sustainable Development

 Involve effectively member states governments in defining policy for: responsible and sustainable fisheries; poverty alleviation; improvement of working conditions in small-scale fisheries operations, with a special focus on women; comanagement of marine resources; promotion of responsible and sustainable fisheries under all legal forms (including by protecting the environment coastal ecosystems against all forms of pollution degradation detrimental to the resource and by committing to

combat illegal fishing and bad fishing practices);

- Integrate technical and technological innovations into efforts to ensure rational and sustainable use of resources;
- Prevent and work at resolving conflicts arising from the cohabitation of fishing communities and/or from different fishing gear and exploitation types, etc;

## Develop a communication strategy

- Provide members and players of the sector with reliable and relevant information allowing them to better understand problems, issues opportunities of the sector in order to facilitate their involvement and their effective participation in the implementation of policies, programmes and projects concerning them;
- Elaborate a communication plan;


#### The vision
